Submission requirements



For the Energy Networks Women in Networks Award 2024

Guidelines

All entries must adhere to the following guidelines:

- **Eligibility:** The 2024 Women in Networks Award is exclusively available to fully financial members of ENA for the relevant calendar year. Regulated electricity and gas networks are eligible; however, associates, affiliates, and external business partners or suppliers are not eligible.
- **Nominations:** Any ENA member company may nominate an individual from within its own organisation or another ENA member.
- Nominee: The proposed nominee must be an employee of a fully financial member of ENA.
- Submission Limit: Entrants may submit up to two entries in this category.

Women in Networks Award Criteria

- Nominees will be evaluated based on their significant contributions to the energy network industry, whether they are seasoned leaders or emerging talents. Provide a short summary of the nominee, including their background and how they contribute to making a difference in the industry. Nominees may meet one or more of these criteria. Give examples of how the nominee:
 - **Drives innovation:** Leads groundbreaking projects or initiatives that have advanced the energy networks sector.
 - **Exhibits leadership:** Demonstrates leadership roles and their impact on their organisation and the broader industry, including mentoring and influencing others.
 - **Excels in professional roles:** Achieves excellence in their professional roles, whether in STEM or other fields, and drives advancements within the sector.
 - Contributes to net zero targets: Makes significant efforts and successes in contributing towards Australia's net zero targets.
 - **Engages with the community and customers:** Actively participates in community and customer engagement, leading to improved relations and involvement.
 - **Promotes diversity and inclusion:** Acknowledges and embraces diversity, serves as a role model, and leads and/or mentors' others to promote equality.

Word Limit: Entries must adhere to a total word limit of 1000 words, split as follows:

- 500 words for the Contribution Summary
- 500 words for Examples of Contribution

- Include Multimedia:
 - You may submit up to five images and videos.
 - For each image and video, provide a description (e.g., Figure 1. write a brief description)
 - Send images as separate files or through online file sharing and provide links for videos.
