

# **2024 Individual Contribution Award** (Expanded Eligibility)

In 2024, the Individual Contribution Award evolves to more broadly recognise and celebrate significant achievements within the Australian energy network sector. Previously focused on members of ENA Committees or Working Groups, this year's award expands its scope to include contributions from all employees of full members of Energy Networks Australia (ENA).

This award is specifically intended for individual contributions, recognising significant achievements at all levels and honours those whose groundbreaking work in areas such as asset management, consumer energy resources, operations, environmental strategies, business models, customer engagement, safety, and advancements in networks has substantially contributed to the sector and improved outcomes. Additionally, it acknowledges exemplary leadership that has driven significant improvements and innovations within the industry or community it serves.



### Eligibility

The 2024 Individual Contribution Award is open to regulated electricity and gas networks that hold full membership with Energy Networks Australia (ENA).

## **Submission requirements**

### Guidelines

#### All entries must adhere to the following guidelines:

- **Eligibility:** The 2024 Individual Contribution Award is exclusively available to fully financial members of ENA for the relevant calendar year. Regulated electricity and gas networks are eligible; however, associates, affiliates, and external business partners or suppliers are not eligible.
- **Nominations:** Any ENA member company may nominate an individual from within its own organisation or another ENA member.
- Nominee: The proposed nominee must be an employee of a fully financial member of ENA.
- Submission Limit: Member organisations may submit up to two entries in this category.

### **Industry Contribution Award Criteria**

- Nominees will be evaluated based on their significant contributions to the energy networks industry. These contributions can be demonstrated through activities, initiatives, or leadership in areas such as: Asset Management, Distributed Energy Resources, Operations, Environmental Strategies, Business Models, Customer Engagement, Safety.
- **Nominators** must use the nomination form to provide detailed examples of the nominee's impactful initiatives and/or leadership. These examples should clearly demonstrate:
  - The nominee's significant achievements within the sector.
  - How these contributions have led to pivotal innovations or significant improvements for customers, communities or the industry.

#### Word Limit: Entries must adhere to a total word limit of 500 words

• Nominators are encouraged to provide multimedia, such as images and videos, to supplement their written descriptions and further illustrate the nominee's contributions.

#### How to make your submission

- Submit your application: the nomination form is on the last two pages of this document.
- Include Multimedia:
  - You may submit up to five images and videos.
  - For each image and video, provide a description (e.g., Figure 1. write a brief description).
  - Send images as separate files or through online file sharing and provide links for videos.
- Submission Deadline: Email your completed application to awards@energynetworks.com.au by close of business on 9 July 2024.
